Stadium rules

The internal rules of procedure shall apply in all football stadiums, excluding the special provisions included in art. 15

1. The Rules of Internal Order (RIO) applies in the entire complex of the Jan Breydel Stadium during the football matches organized by Club Brugge (hereinafter called the organizer).
The people entering this complex should take notice of these Rules, they shall accept these Rules and abide by them.
2. Any person who wants to enter the premises of the stadium must be in possession of either a ticket or a special authorization granted by the organizer that proves they have the authority to enter the stadium. With this entrance pass, a single one time access to the stadium is granted. Any person in the stadium, must be in possession of this ticket or the special authorization pass at all times.
3. The individual needs to take place on the location and area in the stand which are mentioned on the ticket/pass. It is strictly forbidden to go to or be in another stand or area of the stadium, or to occupy another place, other than that one listed on the ticket without the prior agreement of the security officer. The purchaser or transferee and any transferor of the pass or the special admission is indivisibly and severally liable together with the ultimate holder for any damage caused by the holder in the stadium.
4. Access to the stadium is refused or forbidden to any person:
 - Under the influence of alcohol, drugs or any other stimulant;
 - Whom have a stadium restriction imposed by either an organizer or a national or international football association or federation, or administrative or judicial authorities;
 - Those whom demonstrate their obvious behaviour to disturb the public or to provoke injury, hate, anger
 - Those whom are denied access to the stadium under the second paragraph of Article 5. of the Rules of Internal Order, by the steward

In case of the organizer refusing a person the right to access the stadium for security reasons or for the same reason is removing him, neither the organizer nor the distributor need to refund the ticket.

5. Each ticket holder or holder of a special authorization entering the stadium allows his ticket or pass to be checked by the steward. Stewards will invite ticket holders of the same sex as theirs, to undergo a voluntarily superficial inspection of clothing and bags in order to detect objects which are not allowed in the stadium and which may disturb the game or could endanger the safety of the supporters and the overall public security. The stewards have the right to seize any objects found in your possession which are not suitable for entering the stadium.
Access to the stadium will be denied by stewards to anyone opposing to this inspection, refuses to hand over any forbidden objects, and to anyone who in any way contravenes with the one or more articles of these Rules of Internal Order. Some objects such as motorcycle helmets, Etc.. can be stored with the steward until the end of the game. The depositor gives these objects freely for free storage and obtains a ticket. When the game is finished, the object is returned to the rightful owner only after issuing the ticket. Articles 1915 and 1954 c of the Civil Code apply here.

6. The holder of a ticket/special authorization to enter the stadium, and the persons present in the stadium, are forbidden to bring into the stadium, to let be brought by others into the stadium or to be in the possession of the following items:
 - alcohol, bottles, cans, drugs or any other stimulant
 - projectiles or explosives in solid, liquid or gas form
 - flammable products or materials, aerosols
 - pyrotechnic objects such as Bengal firework
 - Any weapon or dangerous object that could be used as a weapon (sticks, chains, cross-impact or impact weapons)
 - Anything that can be used as means to disrupt or bring danger to the order or safety of the crowd, and/or damage property and people.
 - Animals are not allowed in the stadium unless permission is given by the Security officer
7. For the holders of a ticket or a special authorization it is strictly forbidden, in the Stadium to:
 - take image or sound recordings of the game for any other reason than personal private, non-commercial use, without the agreement of the Pro League/VV/ACFF or the RBFA. This restriction is not meant for the official press, photographers, film recorders or journalists, as far as they abide by the rules and regulations set forward by the organizer within the limits set by their accreditation or in as far as they are doing their job as prescribed within the boundaries of the contracts made up between the Pro League/VV/ACFF or the RBFA and the commercial and/or media partners. In all cases it is forbidden to sell photographs for commercial use without the agreement of the photograph holder (player, club, Etc,...)
 - without any legal or pre-written agreement of the organizer or from the Pro League/VV/ACFF or RBFA, to collect game data, scouting data and/or statistics or to co-work by means of a wireless network or any other way (example life betting or to offer or to facilitate direct gambling) unless for their own non-commercial private matter.
 - to situate themselves in areas of the stadium where their ticket/special authorization does not give them access to, such as service quarters, players quarters, neutral and VIP areas, press quarters, offices, private quarters, the game field,
 - to climb buildings, structures, fences or barriers, lightingpoles, dug-outs, roofs, or any other infrastructure of the stadium and/or to stand up on the seats or benches, during and after the game
 - to block access and evacuation routes, stairways, stairwells, corridors and to occupy any such places longer than is strictly necessary for entering and exiting the stadium
 - to mask or disguise one-self to try to avoid recognition
 - to disrupt the peace and to jeopardize the safety of others
 - to sell or distribute beverages, food or any other products without the firm authorization of the organizer
 - to throw or shoot any objects in liquid form or any other product in loose or gas form in the direction of the game field, the area around the game field or in the platforms or stands
 - to smoke in a none smoking zone
 - to urinate in public

- banners, flags or other objects should not:
 - be hung in front of the bill boards
 - hamper the sight of the game field
 - hamper the evacuation exits
 - obstruct one's recognition
- 8. The use of texts, symbols, chants, indecent gestures and utterances in any way that give rise to racism, xenophobia, discrimination and provocation are forbidden in the stadium.
- 9. Everyone present in the stadium must always follow the guidelines given by the organizer or those designated by the organizer. Individuals who fail to abide by these guidelines will be removed from the stadium.
- 10. For safety reasons the organizer reserves the right to:
 - reseat or remove the holder of a ticket to a place other than the one stated on the ticket
 - to delay, interrupt or stop a game.
 - to temporarily keep spectators in the stadium at the end of the game
 - to fully or partially evacuate the stadium
 - to refuse access to the stadium despite the possession of a valid ticket
- 11. Each holder of a ticket/special authorization issued by the organizer enters the stadium at their own risk. The organizer can not be held liable for any theft and accidents
- 12. In regard to the law of 8 December 1992, for the protection of privacy in relation to the processing of personal data, amended by the act of 11 December 1998, to transpose the directive 95/46/EC of 24 October 1995, of the European Parliament and the council on the protection of individuals with regard to the processing of personal data and on the free movement of such data, the spectator is hereby informed that the organizer collects data and processes it in an automatic file security reasons.
Every person who enters the stadium can be filmed and the images can be registered and stored. The recording and storage of these images by police and/or organizer is done purely in view of ensuring enforcement and compliance of security inside the stadium
The aim of processing these images, sanctioned by the law of 21 December, 2004, on safety at football matches, amended by the Act of 10 March 2003 and the Law of 27 December 2004, is to prevent and detect crimes and breaches of the Rules of Internal Order, and to enable the identification of perpetrators in order to ensure that they can be prosecuted.
- 13. The person who is being denied access to the stadium or whom is obliged to leave the stadium by the organizer or does not comply fully with the Rules of Internal Order may be excluded from attending other football games in accordance with the existing civil exclusion procedures.
- 14. Any person who causes injury to another person and/or goods and/or to the stadium can be criminally prosecuted.
The law on safety at football matches from 21 December 1998 amended by the Law of 10 March 2003, the Act of 27 December 2004 and the Act of 25 April 2007 and its implementation applies within this stadium.
- 15. Specific regulations concerning the "Jan Breydelstadion" stadium:
 - There is a smoking ban – including E-cigarettes – in the stadium at games Club Brugge

- There is a ban on handbags, backpacks, ... larger than A5 size. Supporters who seem to a pocket or bag, will be denied access to the stadium. There are lockers, to as long as supplies last.
- The 211, 212, 213 and 214 boxes are boxes and there is atmosphere during the games of the National League and the cup of Belgium the are not enforced.
- 311, 312, 313.314 and 315 boxes are boxes and there is atmosphere during the matches in the Jupiler Pro League and cup of Belgium the are not enforced.
- It is forbidden to bring drinks, food, paper shreds and paper into the stadium on a roll
- Food and drink are allowed in the stands
- Throwing paper on a roll, shredded paper, confetti and the like is only permitted after prior consent of the responsible security
- It is forbidden to enter the stadium complex in the possession of the bells with pressure gas
- Musical instruments and megaphone are allowed. The wearer of the musical instrument and the megaphone must identify himself with the head steward of the stand
- Flags on stick are allowed under the following conditions:
 - a flag carried by one or two sticks should have the maximum size of 150 cm to 200 cm and should only the logo and/or the club colors and/or the official name of one of the associations playing;
 - The stick must be hollow, pliable to 90 degrees and in one piece and can not splinter when folded. The length of the stick must be between 150 cm and 200 cm;
 - flags/banners with a larger size are allowed into the stadium, provided that prior consent of the responsible security and with the necessary certificates;
 - the flag may not be removed from the stock or sticks.
- Atmosphere events must be requested from the safety manager at least 10 days before the race and are only admitted if they meet the set conditions.
- Unauthorized exceeding of the inner fence is sanctioned with a stadium ban of 2 years and a fine of at least 1000 euros.
- the organizer reserves the right to persons, who have violated the image of the organiser (for example by any means to be involved in disturbances, whether relating to a football game or not), in the stadium refuse.
- Club Brugge can be any damage suffered, i.e. both direct and indirect damage (including fines imposed by UEFA and URBSFA/or), which are the result of offences against ground regulations, integral joint and several stories on the cause (s) of it which the terms of reference (s) violated.

Prohibited Items

Welkom in het Jan Breydelstadion

Volgende objecten zijn verboden in het stadion

Please be aware that the following items are not allowed into the stadium



Scherpe voorwerpen of messen
Sharps, knives or pointed articles



(Bengaals) Vuurwerk of rookbommen
Flares, fireworks or smoke emitting devices



Glazen flessen
Glass bottles



Luchthoorns of laserpennen
Air horns or laser devices



Andere gevaarlijke objecten
Any other hazardous items



Roken is verboden op de aangeduide plaatsen
It is against the law to smoke on these premises

Megaphone & drum

In the visitors section it is allowed to bring 1 megaphone and 1 drum. This is conditional upon the fact that the name of the person bringing the megaphone and the drum is passed on to the security manager.

Tifo's

- To be requested in advance: Text, photo and necessary fire certificates to the safety manager of Club Brugge. This is for approval
- At least 10 working days before the game

Forbidden property in the stadium

- Backpacks and other bags are not allowed in the stadium.
- Objects are confiscated and not returned:
 - A weapon or any object that can be used as such
 - A sharp or blunt object
 - Alcohol, drugs
 - Projectiles or explosives in solid, liquid or gas form
 - Pyrotechnic objects such as Bengal fire, smoke pots, firecrackers, ...
 - Flags, slogans or insignia or symbols that may upset public order or are racist in nature
- Objects that are declined and after the game returned
 - Helmets
 - Selfiesticks
 - Please note that this better be left in the vehicle or on the bus
 - Things that confiscated must be by the visiting steward tracked

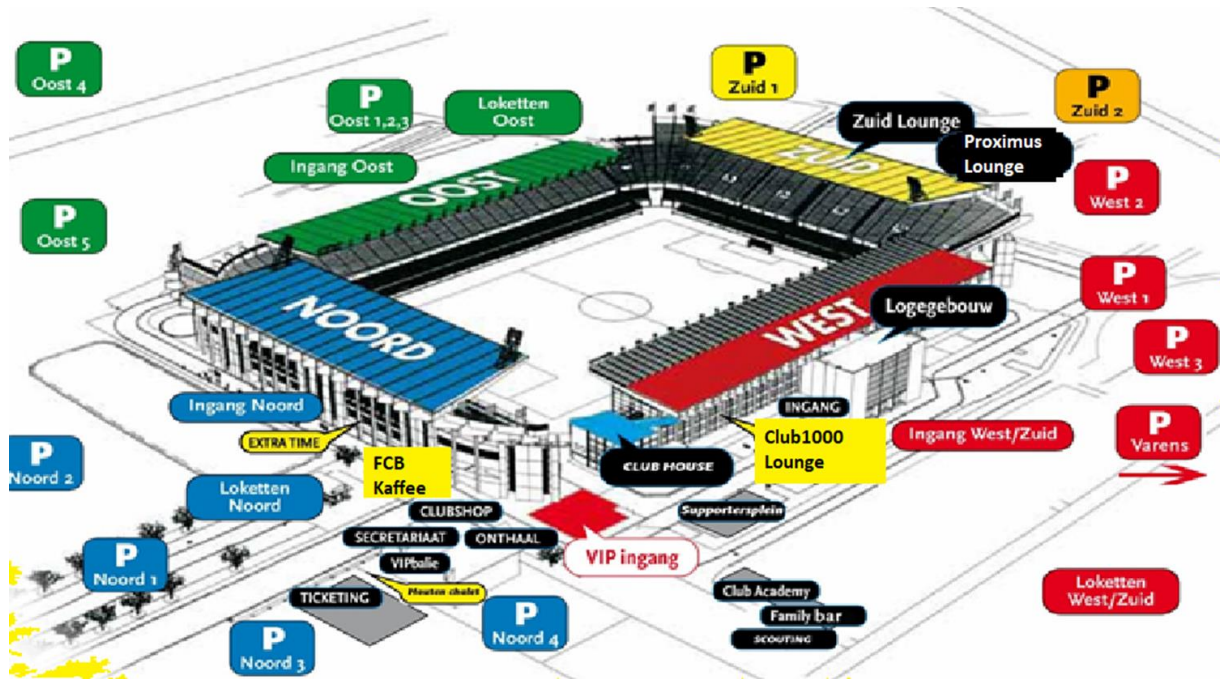
Terror

- Despite the reduction of the level of the terrain, the restrictions are maintained
 - All sports bags, rucksacks and handbags are forbidden
 - No lockers available

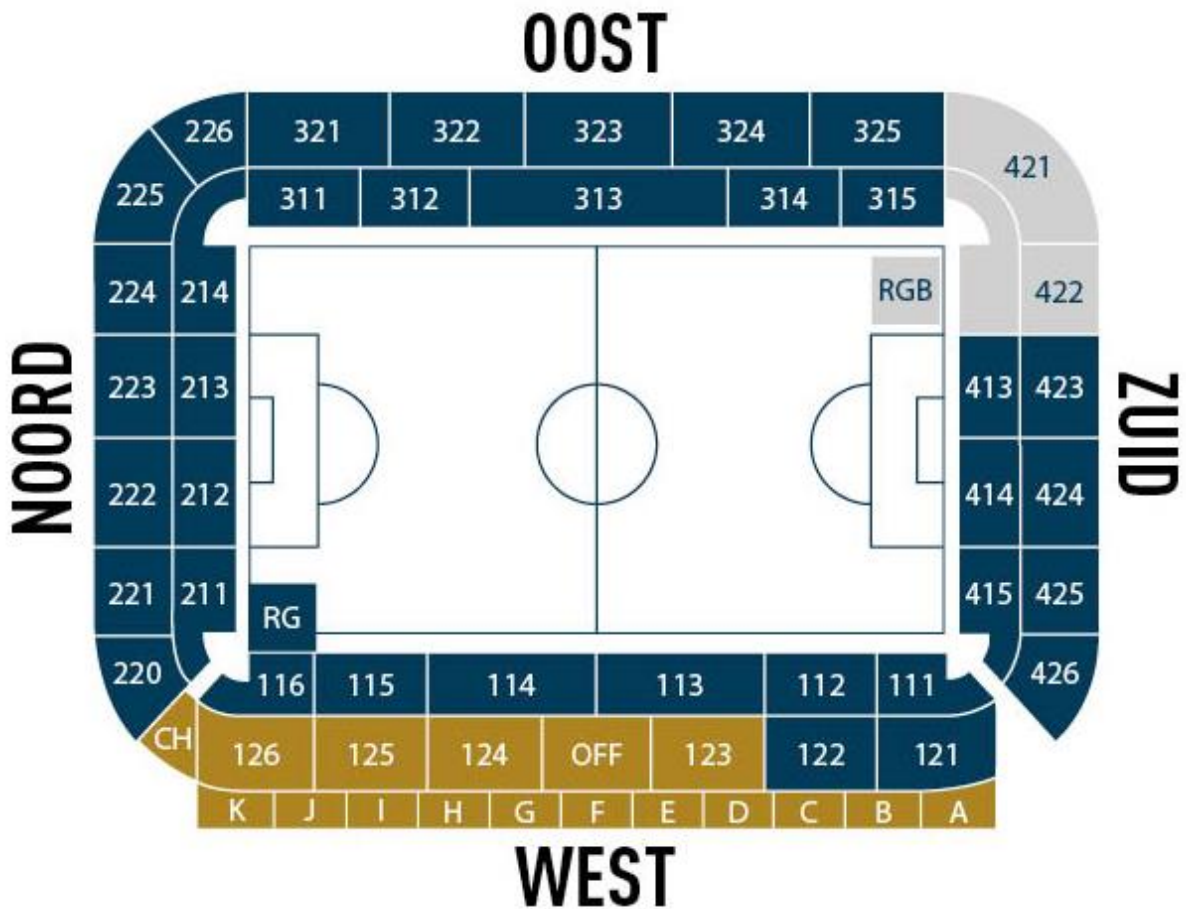
